ELIGIBILITY: Participation is open to artists 13-19. 2D and 3D works are welcome, however 2D work must be mounted or matted or framed to facilitate hanging. Commercial kits, models and hobby crafts are not eligible.

AAUW GP reserves the right to disqualify any artwork submitted, including artwork deemed inappropriate for young viewers. Entries will be handled with all possible care, however, AAUW and University Liggett School are not responsible for loss or damage.

Entries must be delivered between 4 and 8pm on Wednesday, November 10, 2021, to the Manoogian Art Gallery at University Liggett School, 1045 Cook Rd. Grosse Pointe Woods.

JUROR AWARDS: Best of Show \$300, Second Place \$200, Third Place \$100

JUROR: Tresa Baldas has been a journalist for 33 years, covering legal and social justice issues at papers including the Detroit Free Press, the Chicago Tribune, New Hampshire's Concord Monitor and New House Newspapers in Washington, D.C. Over the last decade, while at the Detroit Free Press, she has covered many critical issues and inequalities facing women. She has written extensively on workplace discrimination, domestic abuse, female genital mutilation, harassment, and sexual abuse. Most notably, she investigated and exposed years of hidden sexual assault cases of women tourists at Jamaican resorts. This investigation led to her being named the 2019 Michigan Journalist of the year by the Michigan Press Association.

She earned her B.A. in journalism from Michigan State University, where she met her husband, M.L. Elrick. Their two daughters, Emily, and Sophie, also attend MSU. She is a proud Detroit, having lived on the east side for 22 years, where they raised their daughters.
